PERSONAL PROPERTY SUMMARY Pile No. 2646 July 9, 1946. Re: Macharu TAMURA, Reg. No. 10934 This man signed a declaration to the Custodian on March 24, 1942. He was evaucated on June 1, 1942. In his declaration he reported chattels left under his cabin at Claston, B.C. Mr. Dave Smith visited Claston in April, 1942 and inventoried 11 pieces, which were moved to the company house c/o Mr. H. Cowie. 10 of these pieces were shipped to TAMURA on releases of May 19, 1942 and September 18, 1942. The contents of the remaining carton were sold at auction and the net proceeds in the amount of 39 cents were credited to the account of this man. He reported \$15.00 in War Savings Certificates in his own possession, and a \$1,000.00 endowment policy with the Sun Life Assurance Co. Neither of these items came under the control of this office, but in December, 1943, Sun Life cheque for \$204.77 was forwarded through this office to TAMURA as cash surrander value of his policy. This file reveals no other property of any kind.
