Dear Sir:

Replying to your letter of September 11th, I, File No. 10529, wish to state that the Steveston Nosan Kaisha is not a registered company and that the company owns twenty-five acres of farm land, which is registered by the name of four representatives -- T. Hikida, S. Yoshida, G. Takahashi, and T. Koshiba.

Mrs. Koshiba is one of our members and she has rented four acres of land for the past many years. She has paid rent until 1941 and has not paid for 1942 because the Company did not charge.

Our members had a meeting on April, 1942 before all Japanese evacueed to the interior, and we resoluted that rent will not be charged to the renter from 1942 until we come back to Steveston.

Mr. T. D. Kato, bookkeeper of the Steveston Nosan Kaisha, died on last May 4, 1942, so I am not in a position to give any more details without the Company's books, which are in Steveston.

I hope that the above information will be of assistance to you.
