SUMMARY

On November 17, 1944, following the sale of the real property, and apparently after the removal of goods from 717 and 717 1/2 E. Cordova, we wrote HATANAKA and informed him that none of his chattels had been found.

HATANAKA replied, "In reply to your letter informing us of not finding any of the registered chattels at 717 E. Cordova, I assume they must have been removed or sold by someone else since we did not have time to pack them and left them as they were."

If we accept HATANAKA's statements in regard to his chattels, we cannot overlook the possibility of some of the goods now credited to Yojiro KONDO having been the property of HATANAKA.

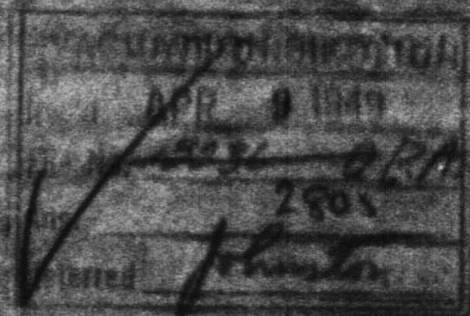
