

Replying to yours of November 3rd, we feel quite certain that we advised you per letter early in the summer months that the net mentioned in your letter was purchased by us, and we paid Naojiro Oya a cash payment in our Vancouver office before any proceedings were ever taken by the Government as all Japanese here were moved from Namu previous to any move being made by the authorities, and the Japanese mentioned above knows fully well that he accepted the money, which was his own property at the time.

We trust this clears the matter up and, if you should require any more information regarding the Japanese that at one time fished from here, we would be very pleased to do anything possible to clear up any matter that may be pending.
