Further correspondence reveals that the cheque was a business debt incurred by Green Cove Salteries Ltd., of which Kashino was a director. Investigation by P. S. Ross & Sons Vancouver agents, disclose that this company was "hopelessly insolvent" as of sept. 1/42.

On registration of Kashino, this office surveyed his asset in the hope that a settlement of this debt might be possible however, the investigation disclosed that he was heavily indebted and had "borrowed to the hilt".

This information was conveyed to Mr. Wyness, and no further action by this office is recorded.
