In regard to letter of October 21, 1942, asking for information about 1930 Model A Ford Tudor, this car was listed as Car 34 and was sold for the sum of \$140.00, from which were deducted expenses of \$25.53. The balance of \$114.47 was credited to the account of Koz o ARAI, Reg. 02774, File 7832, registered owner and father of Yoshio ARAI.

Kozo ARAI was informed of this sale on January 8, 1943. As Yoshio ARAI's address is the same as that of his father, and as Yoshio appears to be the writer of the letters received from Kozo ARAI, we can take it that Yoshio ARAI is aware of the facts concerning the sale of this car.
