MEMORANDUM: File 2828

Feb. 7, 1945.

Re: Yoshio ARAI, Reg. 03110,

In regard to letter of October 21, 1942, asking for information about 1930 Model A Ford Tudor, this car was listed as Car 34 and was sold for the sum of \$140.00, from which were deducted expenses of \$25.53. The balance of \$114.47 was credited to the account of Kozo ARAI, Reg. 02774, File 7832, registered owner and father of Yoshio ARAI.

Kozo ARAI was informed of this sale on January 8, 1943. As Yoshio ARAI's address is the same as that of his father, and as Yoshio appears to be the writer of the letters received from Kozo ARAI, we can take it that Yoshio ARAI is aware of the facts concerning the sale of this car.

Dear Sir:

In your Registration with the Custodian, you declared one bicycle and personal effects at 155 E. 10th Avenue, Vancouver. With the purpose of offering protection to your chattels, our representative visited your former residence where a new tenant informed him there was no bicycle on the premises, and we, therefore, assume that you disposed of this article before your evacuation. We will be pleased to hear if you took the balance of your personal effects with you to Grand Forks. Without further information from you after your Registration, we must assume that you have no other personal property in the restricted area of British Columbia requiring our protection. Kindly acknowledge by signing and returning the attached copy of this letter for our record.
