ACCOUNTS RECEIVABLE: The account of FUJIWARA was credited with the sum of \$6.76, being a refund of 1% wage deduction. This was remitted by the Custodian to FUJIWARA on Jan. 4/44, closing his account.

WAR SAVINGS CERTIFICATES: FUJIWARA declared two \$10.00 War Savings Certificates in his father's possession. These were not brought under the control of the Custodian.

No property interests other than those mentioned above are found on this file.
