ENERAL SUBJECT Place No. 2246 Genya TADA, Dectd. Reg. No. 07140 Genya YADA died at the Vancouver General Hospital on August 13, 1947. He was survived by his widow, Shige, File 8279; and three sons, Genichiro, file 3312; Hideo, file 4580; and Gengi, file 8534. The only assets declared by the deceased were a few chattels at 3390 East Bastings Street and a \$1,000.00 Crown Life Insurance Company Endowment Policy, beneficiary being his wife, Shige. According to a memorandum on file dated February 23, 1944, signed by Mr. Spain, Mr. Yada visited Vancouver in December 1943 and either liquidated his chattels or shipped them to the interior. On September 11, 1947, the Grown Life Insurance Company advised us that they had paid the sum of \$771.69 to Shige Yada, being the value of the endowment policy in the name of the deceased. The only claim filed against the deceased was a Judgment in favour of Sukegoro Mori and Tomekichi Hikida against the Lion Lubmer Company Limited, Genya Yada, Genichiro Yada and Genji Yada. Mr. Hikida was advised that there was nothing this office could do with regard to liquidating this debt as neither Yada nor his sons had any funds under the control of the Custodian and we had no record whatsoever of the Lion Lumber Company. This summary is certified to be in accordance with information on file.


