



GENERAL SUMMARY

File No. 2934

2nd October, 1946.

Re: Keizo SAMESHIMA - Reg. No. 10682

The only assets declared by the above Japanese were a War Savings Certificate and 18 Pacific Co-operative Union shares. The War Savings Certificate was not brought under control by the Custodian. SAMESHIMA sent in to this office Certificates covering his redeemable shares in the Co-operative, which consisted of one 1937, one 1938 and two 1939 shares, which have been redeemed at par for \$40.00. We are still holding in safe-keeping two shares issued in 1941 which should be redeemed early in 1947, at which time the funds will be forwarded to him. The remaining 12 shares declared by SAMESHIMA are non-redeemable shares.

Although SAMESHIMA declared no liabilities, three claims were filed against him:

Dr. E.B. Erickson	\$5.00
Royal Columbian Hospital	57.94
Dr. J.P. Sparling	15.00

SAMESHIMA declared in a letter dated 17th April, 1944, that he had paid Dr. Erickson's account. Dr. Erickson was advised of this and notified that the Custodian would take no further action in the matter. The other two claims SAMESHIMA admitted as being correct, and remitted his P.C.U shares for payment of same.

On the 21st Sept. 1946, we wrote to the two creditors asking if they would accept a pro rata payment of 60% in full settlement. The creditors agreed to this and settlement has been made.

There is reference on the file to a Ford Coupe, but this car was surrendered under name of Iwami SAMESHIMA, No. 13550, File No. 3012.

This file reveals no other assets or liabilities.

The above summary is certified to be in accordance with the information on file.


