The above, who made her declaration to the Justodian on April 14th, 1942, and was evacuated on April 23, 1942, declared no chattels in the protected area. At the time she was an unmarried girl of 16, her name being Shizuko HASHIMOTO. She later married Fujio YOSHIMOTO.

SPECIFIED ARTICLES:

Although the above did not declare a radio, we were advised by the R.C.M.P. that she had surrendered a Marconi radio to them on March 10th, 1942. This was handed over to the Gustodian on April 25th, 1944, and was sold at Vancouver auction No.24 for the net sum of \$14.14, and this amount credited to the account of the above with this office. She was advised of this sale on January 3/45 at which time we informed her that the funds would be available to her if she would remit us the receipt she received from the A.C.M.P. at the time the radio was surrendered. We have had no reply to this office.

The above declared one \$5.00 War Savings Certificate in her own possession. This did not come under the control of the Gustodian.
