This was lived in a rented house at 203 Powell Street. He was evacuated on July 10,1942. He signed a declaration to the Custodian on April 14,1942.

In his declaration klikaso declared the following chattels at 203 Powell Street: Sewing Machine \$250.00; furniture, household effects & kitchen utensile \$700.00. On November 13,1942, we wrote KUMANO and informed him that Custodian representative had visited 203 Powell but had found nothing there and we assumed that he had disposed of his goods. He replied that he had left at 203 Powell at the time of his evacuation the followings

1 Lasp Stand 3 Cupboards 10 Chairs

3 Tables

1 Wooden Box with Goods 1 6-gallon Jar

2 Beds & Springs

A memorandum from Mr. Spain, dated December 9,1942, States that the personal ty of Milliano were undoubedly removed from 250 Borell Street to 992 property of Siliano were undoubtedly removed from 250 Foreil Street to 772.

This shipment accounted for all but 3 bundles of dolls of the goods which Mrs. Kames KUMANO, File 11891, had declared to the Castodian on July 27,1942. Mrs. KUMANO did not heave the protected area until September 9,1942, and it is possible that she may have disposed of the other articles.

Some festival dolls which were credited to the account of Masaye MAKAMANA, File 6042, and which had been removed from 250 Powell are believed to be the property of Mrs. KUMANO, and the proceeds of their sale are being transferred to the account of Mrs. KUMANO.

No other property is revealed by this file.

No liabilities are revealed by this file or by the file of Mrs. KUMANO.
