PERSONAL PROPERTY SUMMARY

July 26, 1946.

RE: Kaichiro NAGATA, Reg. No. 05399

CHATELS: The above, who made his declaration to the Custodian on April 14/42 and was evacuated on April 30/42, declared no chattels. However from a freight bill on file dated March 20/42, it is noted that the above had 5 boxes of household goods shipped to him at 561 Powell St., Vancouver from Port Alberni, by the C.P.R. We assume he took these with him when he was evacuated.

The file reveals the above owned no specified articles.

MONIES RECEIVABLE: The account of the above was credited with the sum of \$5.41, being a refund of 1% wage deductions for the first six months of 1941. A Custodian cheque for this amount was remitted to NAGATA on Feb. 10/43.

His account was also credited with the sum of \$45.30, being a National Defense Tax refund. This is his entire balance with this office and a Custodian cheque for this amount is being remitted to him in the course of the next few days.

WAR SAVINGS CERTIFICATES: The above declared \$50.00 in War Savings Certificates in his own possession. These did not come under the control of the Custodian.

LIFE INSURANCE: The above declared a life insurance policy in the sum of \$1000.00 with the Prudential Life Co. This policy did not come under the control of the Custodian.

No property interests other than those mentioned above are found on this file.
