This woman signed a declaration to the Custodian on April 14, 1942. She was evacuated on May 28, 1942.

In her declaration she reported chattels left at Port Alberni. A notation from H.G. Hinton on the back of the declaration states that 14 pieces were stored. Of these 12 pieces were shipped on May 22, 1942 to Mrs. NAGATA. Mr. Burnip informed us verbally while in our office on June 12, 1946, that the other 2 pieces were shipped on August 6, 1942, to Mrs. NAGATA.

She reported a bank account with the Bank of Montreal, Vancouver, with a balance of \$200.00. This did not come under the control of this office.

The R.C.M.P. Handed a Brownie Box Camera to this office, which had been surrendered by this woman. This camera is still on hand. maked & secret
