Dear Sir:-

We are in receipt of your letter of the 23rd ultimo in respect to funds on hand here to the credit of your father NAOTO OIKAWA, Reg. No. 04760.

On receipt of same we took the matter up with the Department of Labour, Japanese Division, Vancouver, and have just received a reply as follows:-

"We have for acknowledgment your letter of the 30th ulto.,

According to our records no funds are now held by you on behalf of Katsushige, and as his parents are residing in our New Denver Project we cannot recommend that their funds be released to them.


As far as we know Mr. and Mrs. Oikawa have expressed no desire to leave New Denver to take up residence in Ontario."

It will therefore be necessary for you to take the matter up with your father and have him discuss his plans with the Department of Labour, New Denver, where he is residing, so that they will be in a position to advise this office regarding the release of his funds. On hearing from him and the Department of Labour, Japanese Division, we shall give consideration to the matter.
