Selicize St. but to bioyole was found mong their possessions. Be Japanese gone were found at 8828 Selicize St. when the tenant took over after the FUJICEA family lock. It would therefore appear that Yoshiharu took his biggale with him at the time of his evacuation or disposed of it priot to their time. He also declared three \$5.00 War Savings Certificates. There were not brought under the control of the Custodian. No property interests other than those mentioned above are found on this dise.
