GENERAL SUMMARY

RE: Yoshiharu FUJIOKA, Reg. No. 00446

Yoshiharu FUJIOKA made his declaration to the Custodian on April 13/42 and was evacuated on April 16/42. He declared a C.C.M. bicycle at 8828 Selkirk St. where he was living with his parents, Mr. and Mrs. Ionesaku FUJIOKA.

The chattels of the father and mother were found at 8814 Selkirk St. but no bicycle was found among their possessions. No Japanese goods were found at 8828 Selkirk St. when the tenant took over after the FUJIOKA family left. It would therefore appear that Yoshiharu took his bicycle with him at the time of his evacuation or disposed of it prior to that time.

He also declared three \$5.00 War Savings Certificates. These were not brought under the control of the Custodian.

No property interests other than those mentioned above are found on this file.
