



PERSONAL PROPERTY SUMMARY


Re: Yoshio IKEDA - Reg. 11475.

Yoshio IKEDA made his declaration to the Custodian on April 13th, 1942, but the date of his evacuation is not recorded.

- CHATELS: He declared that some household furnishings were left at his former residence in Ruskin, D. C., but a pencil notation on his declaration form states "Declarant stated, nothing left - given away 16/4/42". No further evidence of the effects is revealed on the file.
- SPECIFIED ARTICLES: Although he did not declare it, the file reveals that a 14 foot rowboat sold by J.F.V.D.C. at Ocean Falls was identified as his and the sale price of \$8.00 less expenses of .08 was credited to his account.
- SAVINGS: Ikeda declared he had 12 War Saving Certificates, \$5.00, in his own possession. These did not come under the control of the Custodian.
- LIFE INSURANCE: His Mutual Life Insurance Co. Endowment policy #530505, in the amount of \$1000.00, the beneficiary of which was his wife, Sueno, file 3564, remained in his possession and was not brought under the control of the Custodian.

Yoshio IKEDA stated in letter of 14/12/43 that he had left a boat at Ocean Falls. Other persons of this name, who formerly lived at Ocean Falls, were written to in an effort to find owner of boat left there, and this man was the only one that replied.

Naval Service reported this boat as being owned by M. IKEDA.
