I represent the Alberni Pacific Transport Company Limited and on their instructions have been checking through their files to ascertain the status of the Titles to their property. The Company owns Lot 2 and has been paying taxes on it for the past 10 years. This property is registered in the name of two Japanese. One of them, Yoshigoro Kawaguchi, purported to sell all of the land to my clients., the other owner having gone to Japan. For your information, I enclose a Deed of Conveyance of Kawaguchi to my clients, a Confirmatory Agreement and also a Conveyance of the one-half interest of Kichimatsu Shioji of his one-half interest to Kawaguchi. You will notice that this second Conveyance has not been properly completed as the Affidavit of Witness was never properly sworn. I think this second Conveyance clearly shows the intent of the Japanese to transfer the land to Kawaguchi and if it had been properly completed the Conveyance from the Japanese to my clients could have been registered.
