

This Japanese person declared a Bank Account at the Bank of Montreal, Hastings & Main, Vancouver. No action regarding this account has been taken by the Custodian.

Accounts Receivable:

In his JP form Yohichi KIKUCHI declared that the following persons owed him money, stating he did not know their addresses, and no amounts were given in connection with these debts:

1. Chosaburo IINOME (File 5618).

This Japanese has no assets of any kind with the Custodian at this time, and was repatriated to Japan in August 1946. KIKUCHI is now being advised to this effect.

2. Jiro OYA (File 3348)

On checking this man's file there is no evidence of Kikuchi's claim having been placed thereon and same was not declared by OYA. We are now writing to Kikuchi asking amount of his claim and if it has been settled direct. *No reply rec'd to our ltr of May 6/47. No further action required.*

3. Masuye ISEZAKI (File 10467)

A check of file 10467 reveals that Kikuchi's claim was not placed thereon and we are now writing to Kikuchi asking amount of claim and if it has been settled direct. *No reply to our ltr May 6/47. June 9/47 re amount of this claim & if settled, therefore no further action is being taken by this office.*

4. Tokue KAMEOKA (File 13802)

Mr. Kikuchi's claim of \$200.00 was submitted to Kameoka on February 1, 1943 and he replied that this owing over ten years and he has an understanding that he does not have to pay it back until financially able and as he is only making sufficient for his board is unable to pay this debt. Kikuchi was so advised on February 27, 1943 and given Kameoka's address that he might contact him direct. *(200.00 trans'd to Kikuchi's acct Aug 2/47 & remitted Sept 12/47 - see ltr July 1/47 to Kameoka.)*

5. Samizo MURAKAMI (File 11442).

This man's file reveals that Kikuchi's claim was never placed thereon and as he has now no funds with the Custodian we are so advising Kikuchi and giving him Murakami's address that he might contact him direct if he so wishes.

NO OTHER PERSONAL PROPERTY OF ANY KIND WHATSOEVER BELONGING TO THE ABOVE JAPANESE PERSON IS REVEALED ON THIS FILE.
