GENERAL SUMMARY

Re: Noboru YOSHIDA, Reg. No. 08603.

The above registered with the Custodian at Hastings Park, as per undated J. P. form on file. He was evacuated on April 29, 1942.

He declared 20 - \$5.00 War Savings Certificates in his own possession. These were not brought under the control of the Custodian.

A refund of 15 Wage Deductions for the period from January to June 1941 amounting to \$5.12 was received from the Provincial Collector. This was remitted to the Japanese on January 10, 1944.

There is no evidence of any other property.

The above summary is certified to be in accordance with the information on file.
