
Please note that the above has been repatriated to Japan. At the time of repatriation, the following transactions took place:


Chattels:

The Evacuee in his declaration of April 13, 1942 declared one spring net and one cohoe net all located in the net house of the New England Cannery, Nass River, B. C. He declared nothing else. The above Japanese made a direct arrangement with Mr. G. E. Windsor, Manager, Wales Island Cannery. The Canadian Fishing Company, Limited sent a statement dated October 22, 1942 to the Evacuee showing 1 skiff sold for 7.50, 1 Spring net for \$50.00, 1 Cohoe Net for \$40.00, less the balance of account owed by Mr. MATSUBARA in the amount of \$6.37, making a total amount of \$91.13. In a letter received from the Evacuee on December 7, 1942, he claims he sold his equipment to Mr. Windsor for the sum of \$165.00. The Custodian's letter of December 16, 1942 to the Japanese informed him of the amount paid by Mr. Windsor for his equipment. The Custodian wrote the Canadian Fishing Co., Ltd. on February 2, 1943 with reference to the difference in price. In a letter of February 4, 1943, the Canadian Fishing Co. states that there was no promise or agreement that the fishing equipment would be bought for \$165.00 but only that he was to receive whatever amount was realized on the sale of the equipment. Mr. MATSUBARA acknowledged that this was satisfactory in his letter of February 17, 1943. All funds were released from the sale of chattels and had been forwarded to the Evacuee.

Specified
Articles:

The above Evacuee declared no boat on his declaration of April 13, 1942. The vessel appears on the first Naval list as "T.M." owned by T. MATSUBARA, impounded at Prince Rupert. The Japanese reported to the Japanese Fishing Vessel Disposal Committee that the boat was tied at Prince Rupert in December, 1941. A possible explanation of the disposal of this boat is that this vessel was examined by the Naval service and left where she was found owing to its unseaworthy condition or left in the care of one of the canneries. If this vessel was sailable it would be assumed that she was sold by her owner prior to his evacuation as he did not declare ownership and has not made any inquiries since in regard to his vessel.

No property interests other than those mentioned are found on this file.



This boat could not be found among those surveyed by Mr. Phillipson.
