This policy was surrendered for cash and on September 10, 1943 a cheque for the cash surrender value of \$72.78 was forwarded through this office. This cheque was returned from the bank for incomplete endorsation and on December 7, 1943, we issued our cheque for this amount to FURUMOTO. The records of the Custodian show that this man was the owner of a fishing boat which was sold through this office and the net proceeds in the amount of \$108.03 were credited to his account and remitted to him to the second and remitted to him to the second the second for the The account of this man was credited with the sum of \$4.29 received as refund of 15 wage deduction for 1941.
