Re: Yokichi FURUMOTO, Registration No. 02026

This man signed a declaration to the Custodian on April 13, 1942. He was evacuated on April 22, 1942.

In his declaration he reported a \$1,000.00 life insurance policy with the Sun Life Assurance Co. This policy was surrendered for cash and on September 10, 1943 a cheque for the cash surrender value of \$72.78 was forwarded through this office. This cheque was returned from the bank for incomplete endorsement and on December 7, 1943, we issued our cheque for this amount to FURUMOTO.

The records of the Custodian show that this man was the owner of a fishing boat which was sold through this office and the net proceeds in the amount of \$108.03 were credited to his account and remitted to him on May 13, 1943. *A Coho net was sold direct by this man for \$100 July 42*

The account of this man was credited with the sum of \$4.29 received as refund of 1% wage deduction for 1941. This amount was remitted to him on February 1, 1943.
