Re: Masako SARUYAMA, Reg. No. 95232

Reference is made to your claim against Masako Saruyama giving as her relative the name of her mother, Mrs. Natsu Saruyama (Mrs. Denjo Saruyama), Police Registration No. 93985.

Our records indicate that Masako Saruyama has no assets whatsoever and is still suffering from tuberculosis. Her mother, Mrs. Natsu Saruyama, who is at present in New Denver, B. C., has also declared to us that she has no assets. We see no prospect, therefore, of our being able to obtain funds towards settlement of your claim against Masako Saruyama.

Insofar as her father, Mr. Denjo Saruyama, Police Registration No. 13080, is concerned, we have to report that we have no knowledge of his assets, as he declared to us that he had none whatsoever.

In view of the above, we are closing our files in connection with this matter.
