Chattels: In his "JP" form Shoso Chashi states that he has no furniture, personal effects, etc.

Bonds and Securities: In his "JP" form Shoso Chashi states that he has in his possession \$25.00 in War Savings Certificates. It does not appear from the file that these came into the possession of the Custodian.

Life Insurance: The "JP" form discloses a \$1000.00 policy in the Sun Life Assurance Company, the beneficiary being Ohashi's father, Tomekichi Ohashi. The premiums are stated to have been paid to the date of the declaration (April 9, 1942) and the policy was in Chashi's possession. It appears from particulars obtained by the Custodian from the Insurance Company that the policy was No. 2186658 and that the premium (\$40.60) was payable annually on September 1. This policy appears to have been surrendered and the surrender value (103.86) was sent by the Company to the Custodian, who forwarded the cheque (which was payable to Shozo Chashi and Tomekichi Chashi) to Shoso Chashi on November 18, 1943. The B. C. Security Commission, however, appears to have claimed one-half of the monies represented by the cheque. See Shozo Chashi's letter to the Custodian November 26, 1943, and the Custodian's reply of December 3, 1943.
