This man signed a declaration to the Custodian on March 20, 1942. He was evacuated on March 21, 1942.

In his declaration he reported logging equipment left at Still-water, B.C. Owing to the inaccessibility of this place all chattels were left there. This appears on "Stillwater Missing Chattel" file.

He reported a \$50.00 Victory Bond in his own possession and a bank account with a balance of \$40.00 in the Bank of Montreal, Vancouver. These items did not come under the control of this office.

He reported a debt owing to him by Ebisazuki Co. of \$26.46. This was referred to P. S. Ross and Sons but to date no settlement has been made. xx

This file reveals no other property of any kind.

This summary is certified to be in accordance with information on file.

In regard to the claim of SATO against M. Ebisusaki Co. for the sum of \$26.46, Yoshikasu SUZUKI, operator of the camp where SATO was employed, filed claim for the sum of \$33.61 representing wages due SATO from the company. This sum of \$33.61, according to letter dated June 16,1945, received from SUZUKI, was paid by SUZUKI to SATO. The sum of \$33.61 received from P.S.Ross & Sons liquidators of M.Ebisusaki Co. was placed to the credit of Yoshikasu SUZUKI.
