MEMORANDUM

TO: MR. H. P. ALEXANDER
FROM: MR. E. V. WRIGHT

Re: Hatt NISHIMURA (in Japan)
Yoshio NISHIMURA (Evacuee)
Yasuo NISHIMURA (Evacuee)

With reference to your memo of the 10th instant, we agree that all correspondence dealing with the property described as Lots 9 & 10, Block 229, D.L. 526 and known as 1652 & 1658 West 2nd Avenue should be left on our file and all correspondence dealing with personal property should be transferred to the file of the respective Evacuee owners.

In the matter of the stock of groceries, stove equipment and rice mill, there is a possible enemy interest in these goods and if the correspondence relating to these items is removed from our file, please see that a notation is made in your files so that before disposition of the goods or the proceeds from the sale of the goods is made, this Department may be consulted in regard to the interest of Hattsumaru NISHIMURA. We understand that he has an interest in the partnership of business operated under name of Hatt Nishimura.
