



The most important thing in these three files is a lease described as lot 12 of the NW quarter of Section 28 Twp 14, Rng 17W, Municipality of Netaqui in the District of San Bernardino.

The registered owners are: Tomochi HIRAKADA and Etsuo HIRAKADA. Etsuo HIRAKADA has legally changed his name to Etsuo HIRAKA.

Title to the property has been vested in the Custodian under 54479.

It appears that HIRAKADA and HIRAKA leased the property to Fukuichi Koriaki, terms and conditions of the lease are unknown. Koriaki in turn subleased the property to Thomas C. Scott for ten months from April 14, 1942, for \$100.00. A few particulars of this lease are in file 5077.

In a letter to Thomas C. Scott of July 10, 1942 this office acknowledged having received a copy of the lease, but it is not in the files. In order to clarify the whole situation, I suggest the following procedure be adopted:

1. The Assessor's Department of the District of Netaqui should be notified of the new name of Etsuo HIRAKADA.
2. A copy of the lease from HIRAKADA and HIRAKA to Koriaki should be obtained immediately.
3. A copy of the lease from Koriaki to Thomas C. Scott should be made.

From the terms of these two leases the responsibility for furniture, farm implements, etc., could probably be established. In any event, copies of these leases are required before anything else can be done.

The registered owners of this property are Tsuneichi HIROKADO and Masao HIROKADO, and Certificate of Vesting in the Custodian has been filed as No. 24575. This Certificate of Vesting covered the interest in this property of the above registered owners and also of one Fugitsugu MORIZAKI. We have from MORIZAKI a Quit Claim Deed in favor of Tsuneichi HIROKADO and Masao HIROKADO and it is desirable to cancel Mr. Morizaki's interest by the registration of the Quit Claim Deed. I understand that you object to the registration on account of the Vesting Order appearing on the Title and that you suggest the Custodian should convey the property with the written consent of the Soldiers' Settlement Board.

I seriously doubt that the Custodian has authority to do so. While under Section 23 of the Consolidated Regulations respecting Trading with the Enemy, 1939, the Custodian may take such a course with respect to enemy property, neither of the parties of this Quit Claim Deed is an enemy as interpreted by the Consolidated Regulations. The registration of the Certificate of Vesting transferred control of the property to the Custodian but I do not find that the Custodian has the right to make a transfer of title. I am bringing this matter to your further consideration and suggest that you may possibly have authority with the written consent of the Custodian to register the Quit Claim Deed. Will you kindly advise me if this suggestion is practicable.

Neither M. Mihara nor T. Hirakado have declared any real property. The 17.44 acre parcel of farmland known as Lot 12, S.W. 1/4 of Sec. 28, Twp. 16, Rng. 793, D.M.S. declared and operated by their brother-in-law, F. Morizaki, is actually registered in the names of "Tansichi Hirakado and Masao Hirakado" (the latter having subsequently changed his surname to Mihara) but on October 5th, 1942 both (Tansichi Hirakado and Masao Hirakado/Mihara) signed a Quit Claim Deed in favour of Fujitaga Morizaki thus confirming the latter's ownership in fact. This Deed has still to be registered but the identity of the property having been established search, vesting certificate, certificate of encumbrance and tax statement have been entered in File 5977, (Fujitaga Morizaki) for administrative purposes.
