
Re: (Mr.) Isakichi YAMADA - Reg. No. 02873.

This Japanese declared on his JP Declaration April 11th, 1942, certain chattels in 6-roomed house on float at Eburne, B.C. On July 17th, 1942, states on JP Form "I am disposing of these articles and do not hold the Custodian responsible for their protection".

Agreement dated 15th day of July, Yamada agrees to sell to T. H. Jones the following property: the net house and residence now situated on the Komori property for the sum of \$250.00; also included in agreement the following property: Two floats, 1 Bluestone tank, 1 net - 140 fathoms less lines 50 meshes deep for \$12.00. These amounts were credited to his account in this office.
