The above named Japanese declared on our Form J card signed April 7th, 1942 that he had no personal or trade debts.

However, Mrs. Toshi Kunimatsu YAGI, File 5404, filed a claim dated April 22nd, 1943, in the amount of \$100.00 against Joe KURAHARA. We wrote to KURAHARA re this claim but received no reply. Therefore, we wrote Mrs. YAGI stating that as we had received no reply from KURAHARA and as we had no funds to his credit in this office we would suggest that she contact him direct.

Dr. N. Uchida also filed a claim against Joe KURAHARA in the amount of \$20.00. This claim was later withdrawn by Dr. Uchida.
