This 28-year old Naturalized-Canadian wife of Ko TESHIMA (File 2250) signed a Custodian "No Property" card on April 7th, 1942. She was evacuated on the 28th May, 1943.

The following is a summary of the contents of this file as disclosed by a review made today.

Personal Property: The only reference to chattels is a release form dated May 16/42. Chattels Department letter dated Jan. 12/44, shows everything shipped except a bed and springs in the hands of former employers. For all subsequent chattels correspondence see husband's file (2250).

Bonds, Shares, etc.: None.


