Suye Ida KOSUGI died at Slocan City, B. C. on September 19, 1943, at the age of nineteen. She is survived by her father, Ueo, file #3845; her mother Iju, file #4456; two brothers and one sister.

The deceased declared no assets to the Custodian and none are revealed on the file.

A claim was filed by the B. C. Security Commission for recovery of the sum of \$80.00 to cover funeral expenses paid by the Commission for burial of the deceased. As Suye KOSUGI had no assets and was not of age at the time of her death, this claim was filed against her father, Ueo, file #3845. In view of the circumstances of this family, the B. C. Security Commission in their letter of January 31, 1945, on file #3845, withdrew their claim.

No other liabilities appear on this file.
