
The above Japanese declared a \$50.00 Victory Bond and \$25.00 War Savings Certificates in his possession. These were not brought under control by the Custodian.

Takeo HIRABAWA also declared a \$1,000.00 insurance policy with the Manufacturers Life Insurance Company. On September 18, 1944 the amount of \$115.05 was paid on this policy by the father and it was charged to his account, File #3841.

This file reveals no other assets or liabilities brought under control by the Custodian and requires no further administration. The file may now be closed.
