In his declaration to the Custodian, April 17, 1942, this man declared a large quantity of personal and household effects, all of which were shipped c/o B. C. Security Commission, Vancouver, B. C. on April 23rd, 1942.

He also reported the following:

- 1 - \$100.00 Victory Bond
- 1 - \$ 50.00 " "
- 27 - \$ 5.00 War Savings Certificates in his possession.

He also declared a bank account in the Royal Bank of Canada, Cumberland, B. C., with a balance of \$2,500.00, and 2 Life Insurance Policies. None of these items come under the control of this office.

On January 19th, 1944, we remitted to this man the sum of \$7.15 which had been received from the Provincial Government as Refund of ~~15~~ Wage Deduction for the year 1941.

His account with this office was credited with the sum of \$87.53 as a proportionate share of the financial distribution of assets of the Royston Saving Association on the basis of 25 shares. These 25 share certificates are on file.

This file reveals no other property of any kind.

As requested by you in your letter of January 7th, we enclose herewith Custodian's cheque for the sum of \$87.53 representing all of the funds standing to your credit in this office.

These funds were credited to your account as proportionate share of the assets of the Rayton Saving Association on the basis of 25 shares.

In your declaration to the Custodian on April 17th, 1942, you reported a quantity of household effects and clothing. Our records show that all your chattels were shipped c/o B. C. Security Commission, on April 23rd, 1942.

The sum of \$7.15 was remitted to you on January 19th, 1944. This money was received from the Provincial Government as Refund of 1% Wage Deductions.

Your Victory Bonds, War Savings Certificates and Bank Account, as well as your Life Insurance Policies, did not come under the control of this office.

It would appear that we have accounted for all the property of every kind left by you in the Protected Area which vested in the Custodian, and in order that you may confirm this and acknowledge the cheque, we are attaching a stamped addressed envelope for your convenience and reply.
