File 1898 both declared ownership to the above described property in their recistorations on their respective files. EGIGHI was written to on July 2, 1942 and was advised that his stepson had declared expensity. EGICHI regular on the 15th July 1942 blosing his letter as follows: "Please schick by form, thanks. This was interpreted to mean that he released all claim to Urable to the Realty and Personalty mentioned. The Administration and Liquidation of both were recorded on the five kind duties. MGUCHI died Sept. 28, 1942 and the file was closed and no assets were regarded as in his Estate. Mrs. MGUCHI, mother of UYEDE did not declare any assets in her registration on File \$4257. The funds arising from the Realty and Personalty were placed to the gredit of UREDE.
