This man registered with the Custodian on April 15th, 1942 and declared only furniture and household effects in a movable log house on land owned by the Homalco Logging Co. Ltd., Eburne. He declared he had been given permission to move this house. This Company advised us on May 6th, 1943, that this house had been moved to some other location not on their property. This man was written to several times and finally on August 24, 1945, he was advised that failing to hear from him the Custodian would assume that he had made his own arrangements as to the disposal of his house and effects and that we would have no further responsibility in the matter. We have heard nothing further from him.

The file reveals that a cheque for \$5.72 was sent to this man for a 1% wage deduction for the first six months of 1941. This represented his total balance and closed his account with the Custodian.

No property interests other than those mentioned are found on this file.

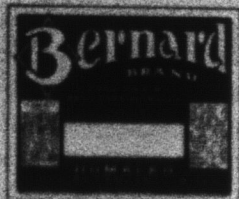
