On December 4, 1944, we wrote you informing you that a radio reported to have been surrendered by you had been sold for the net sum of \$20.75. We informed you at that time that it would be necessary for you to send us the receipt given to you at the time the radio was surrendered in order that the funds might be made available to you. We do not appear to have heard from you since that time.

It is possible that you have not been able to find the receipt. If so, the enclosed declaration, signed by you, will be accepted in place of the missing receipt. If you have the receipt, please send it.

When we have received the receipt or the completed declaration, we shall send you the \$20.75.

If we do not hear from you by March 24, 1947, we shall assume that you have no interest in the proceeds of the sale of this radio, and these funds shall be transferred from your account.
