After considerable correspondence we have succeeded in getting a reply from SHIOMI through the B. C. Security Commission, from which the following is an extract.

We have interviewed the above person who has a wife and three children. His earnings for April were \$42.30. The majority of the debts he and his wife admit, but are doubtful of three, but it is absolutely impossible for any of these debts to be settled out of their earnings.

This man states that if he is able to earn sufficient after the present conflict he will make an effort to repay.

The enclose the list of claims, a notation having been made against each claim by our Supervisor."

SHIOMI admits Nos. 2 and 3, but does not admit No. 1. As he has no funds with the Custodian, and as you will see from the B. C. Security Commission letter he does not seem to be earning very much at the camp where he is situated. Under the circumstances, we regret we are unable to do anything further to assist you in this matter.
