- 2. That I had in my possession and control at Vancouver, B.C., an M.C.A. Victor radio.
- 3. On March 9th, 1942, I delive ed the said radio to the Royal Canadian Mounted Police at Vancouver, B.C., and obtained a receipt therefor.
