Dear Sire Ret Policy #477,508 - Chieve PUKAMI (and Antinon To) Absolute Owner & Beneficiary - Katsubei FUKANI Mr. Katsubei FUKAMI, the owner and absolute beneficiary of this policy, whose present address is c/o R. Clifton, Coalhurst, Alberta was evacuated from Vancouver to that point. The records of the policy were transferred to our Branch and on checking up the premium arrears I find that the amount outstanding with interest to July 1st comes to \$349.20. Mr. Fukami wrote on June 14th as follows:-"Re Policy #477,508 of Miss Chieve FUKAMI. Please collect back premiums payable to you on this policy from the Custodian of Japanese property. Whereas my former means of income has been mullified by our evacuation from our former place of residence and whereas the income received from our present occupation is insufficient to make any payments on future premiums, please declare a moratorium on premiums on this policy. As enclosing a note to be forwarded to the Custodian permitting him to make such payments on back payments as required." Find attached a letter addressed to the Custodian's Office, authorizing payment of the arrears. We would appreciate hearing from you. I might say that it would be desirable not to surrender this policy for a paid-up Endowment at the present time. It would be desirable to pay the further premium falling due on the 1st of September next of \$46.85 and so continue the policy until the 1st of September, 1944 when the third quinquennial dividend will be declared.
