Mr. Mitsujiro HOGUCHI who owned the house
sold it in July to Mr. Greene, and such being the
case, we have no doubt he either sold the chattels
or made arrangements for the storage of same.

Reference to the sale is contained in
your letter to us dated March 29th, 1943.

We would suggest that your supervisor in
Sloona City ask Mr. Hoguchi what he did with the
chattels prior to his evacuation.
