According to information supplied by Japanese this boat was actually owned by Kentaro Hamanishi and mortgaged to B. C. Packers for \$100.00.

The gasboat license, however, was in the name of B. C. Packers Ltd., and she was released to the licensed owners on April 24, 1942.

This boat had been tied at Beaver Cannery, Rivers Inlet, B. C.

There was no claim for damage or loss.

There is nothing to indicate that Hamanishi had an equity in this vessel. *He was a miner at time of emancipation. He did not declare ownership in his return registering.*
