At the request of the above in her letter of Dec. 10/45 the bedroom suite was sold to Mrs. Norton for \$50.00. We received payment in full from Mrs. Norton as per receipt No. 13724 on file and this money was credited to the account of the above in this office. Custodian cheque for this sum was remitted to the above on July 19/46. A mantel clock was shipped to Yoshio KOCHI, File 691, father of the above on Oct. 8/43 against a Custodian release dated June 24/43. This man wrote us on Oct. 26/43 and stated that the clock we shipped to him belonged to his daughter, Mrs. Sadako KONISHI, so he would not send it back. We advised her of this in our letter of Nov. 10/43.
