MEMORANDUM

May 29, 1944.

Re: ASAI, Yukiko (Mrs. Tadaichi)
File No. 4532.

In a letter of February 8, 1943 from T. Kawase (File 5552) it states that he has bought the Asai house, and in a letter of May 4, 1944 states that the chattels from the Asai house are stored with his own effects in a room in the basement of his house at 739 No.4 Road which is completely sealed up.

Mr. Leslie Gilmore is a lessee of the property and occupant of the house.

As ^{the} room in the basement has never been opened by the Custodian it can only be assumed that the chattels of the above are therein.
