Shinkichi KAGAYAMA died at New Denver, B. C. on May 9, 1947. He is survived by his widow, Shisuyo, file #10271; two sons, Shinobu, file #14394, and Tomi, a minor; and two daughters, Yukiko, file #12161 and Toyoko, file #10272.

The only assets declared by the deceased were chattels left at 102 Heatley Avenue. These chattels were not found and it was presumed that they were disposed of prior to evacuation. The widow was asked to advise if this was not the case and no word has been received from her.
