He had been evacuated on September 14, 1942. In his declaration he reported a pump, 2 boxes of dishes and an electric heater left at the Hillcrest Lumber Co., Duncan, B.C. These were sold at auction on February 10, 1944 and the net proceeds in the amount of \$4.91 was credited to this man. 100 lbs. of sugar were seized by the R.C.M.P. prior to this man's leaving Duncan and this was turned over to this office, sold by us and the net proceeds in the amount of \$3.98 were credited to the account of this man. The account of this man was credited with the sum of \$6.28 received as refund of 1% wage deduction for 1941. This file reveals no other property of any kind.
