C Pillo No. The above-named is applying for Old-age Fension and resides at Aelowna. According to his application form he was born on March 21, 1880, and gives his residence as follows:-May 8, 1913, to May 18, 1942 - Steveston, B.C. May 20, 1942, to April 15, 1945 - Kaslo, B.C. April 15, 1945, to April 16, 1946 - Lemon Creek, B.6. April 18, 1946, to Nov. 8, 1948 - Raymond, Alberta Nov. 10, 1948, to March, 1950 - Westbank, B. C. It is noted that this applicant did not go to Alberta until April, 1946, several months after the end of the war. In view of this we are wondering if this Japanese could be considered as an evacuated Japanese who was moved to another province as a temporary resident under arrangements and agreements between the Federal Government and Provinces? In other words, did this applicant go to Alberta under exactly the same arrangements as those who were actually evacuated during the War? Could you also please let us know by whom his fare was paid?
