CHATELS: The above, who made his declaration to the Custodian on April 21/42 and was evacuated on May 15/42, declared nets and fishing equipment at the Gulf of Georgia Cannery net house. All nets found tagged with the name of the above were inventoried by Custodian agent, C. C. Robinson, and have been sold for a total of \$126.00 as shown on the net statement of Feb. 7/44 on file, and this sum credited to the account of SHOJI with this office.

The file reveals the above owned no specified articles.

BANK ACCOUNT: The above declared a savings account in the Royal Bank of Canada, Steveston, in the sum of \$200.00. This was not brought under the control of the Custodian.

LIFE INSURANCE: The above declared a life insurance policy with the Sun Life Assurance Co. #2264066, in the sum of \$1000.00, the beneficiary being his father Tsunejiro. The Sun Life sent us on Dec. 23/44, a cheque for the cash surrender value of this policy in the sum of \$101.02, made out jointly to the above and his father. This cheque was remitted to Genji SHOJI on Dec. 29/44.
