
Minato SASAKI declared on April 20th, 1942, that he owned no property whatsoever in the restricted area, and none is revealed on his file.

The Custodian however, received on his behalf a refund of \$1.53 from the Provincial Collector representing 13 wage deductions for the first six months of 1941.

This amount is now being paid to SASAKI and closes his account.

The Matsqui-Sumas-Abbotsford General Hospital filed a claim of \$2.00 against a M. SASAKI, the Custodian advised Minato SASAKI of this but he denied having had any services from the Hospital. The hospital was requested to further identify their claim and as they did not do so, they were advised in 1944 that no further action would be taken by the Custodian.
